The van will be used by Animal Control. Two (2) of the Ford Interceptor SUV's will be paid from the Federal Drug Asset Forfeiture Fund 296 629626494 for a total cost of \$55,580.00. The 3rd Ford Interceptor SUV and the Ford Transit Connect Van will be paid from the Police Department Vehicle line item 100 607526493 for a total cost of \$46,380.00.

B. Handicap Parking Request – 1115 Berwick Blvd.

The police department recommends that parking be limited to handicapped parking only on the north side of 1115 Berwick Blvd., which would actually put the handicap-parking stall on Crescent Ave., 20 feet east of Berwick Blvd. The department also recommends that city yards erect a sign and paint a parking stall on the north side of 1115 Berwick Blvd., which would put the stall on Crescent Ave., 20 feet east of Berwick Blvd.

Same – Two-Way Stop and Yield Intersections Enumerated.** Sunderlin Street, as the right of way street, and George Avenue, as the stop street, would have to be repealed/removed.

G. Amhurst Parkway Parking Restrictions

The Waukegan Police Department received a request for parking restrictions on Amhurst Parkway west of Lakeside Drive. Parked semi-trucks are blocking the fire hydrants, business driveways, and the cul-de-sac. The police department recommends that the following parking restrictions be put in place.

1. A "No Parking Any Time " (arrow pointing west/right) should be posted on the south side of Amhurst Parkway at 672 feet west of Lakeside Drive.
2. A "No Parking Any Time " (arrow pointing west/right) should be posted on the south side of Amhurst Parkway at 828 feet west of Lakeside Drive.
3. The entire north side of Amhurst Parkway, west of Lakeside Drive, up to and including the cul-de-sac, should be posted "No Parking Any Time."

The change will be covered in **Section 21-120 Parking prohibited at all times on specific streets:**

1. Amhurst Parkway, south side, starting at 672 feet west of the west curblineline of Lakeside Drive, continuing west, up to and including the entire cul-de-sac.
2. Amhurst Parkway, north side, from the west curblineline of Lakeside Drive, up to and including the entire cul-de-sac.
