Notice is hereby given that the City of Waukegan, Illinois will hold a virtual public hearing on **June 15, 2021 at 5:00 PM**, via ZOOM.

The purpose of the public hearing is to receive comments on a revised allocation of the City of Waukegan's PY 2021 Annual Action Plan. The City intends to submit its Amendment to the PY 2021 Annual Action Plan, in the amount of \$797,247 in Community Development Block Grant (CDBG) funds and \$6,000 in reprogrammed funds from the 2020 Program Year for a total of \$803,247, to the U.S. Department of Housing and Urban Development (HUD) on or before August 16, 2021.

In order to obtain the view of residents, public agencies and other interested parties, the City of Waukegan will place its Amendment to the PY 2021 Annual Action Plan on public display beginning on Wednesday, June 9, 2021 through Tuesday, June 15, 2021 at the following locations: Waukegan City Hall, CDBG Office, 3<sup>rd</sup> Floor, 100 North Martin Luther King Jr. Avenue, Waukegan, IL 60085, Waukegan Public Library, 128 N. County Street, Waukegan, IL 60085 and on the City's website at [www.waukeganil.gov](http://www.waukeganil.gov).

This document will continue to be available for public display during normal business hours of operation for a period of three (3) days until 4:00 PM on June 15, 2021. The Amendment to the PY 2021 Annual Action Plan will be submitted for approval at its regularly scheduled City Council Meeting on Monday, June 21, 2021 at 7:00 PM.
